- the prevention of crime and disorder.
- public safety.
- the prevention of public nuisance.
- the protection of children from harm.

The sale by retail of alcohol for consumption on and off the premises is allowed Monday to Sunday from **12 midday to 11:30pm**. Extended hours are available for Christmas Eve and New Years Eve, midday to 1:00am.

Responsible adults shall be in attendance at all times when children are present.

No one under the age 18 allowed to consume, purchase or have alcohol purchased for them. The "Challenge 25" policy has been be adopted and will be enforced on the premises. *Challenge 25 is a policy under which anyone buying alcohol in the UK who looks under 25 years old is asked for ID to confirm their age. It helps to prevent the sale of alcohol to underage people and to reduce underage drinking in the community. It's illegal to sell alcohol to anyone under 18 in the UK.*
